

PRIVACY POLICY

Dear Sir or Madam,

due to the fact that your personal data is in the database of which the owner is MBPOWER.pl Limited Liability Company based in Cracow (Postal Code: 31-752), Makuszyńskiego street 10a, entered into the register of entrepreneurs of the National Register Court proceedings conducted by the District Court for Cracow Downtown, XI Division Economic National Court Register under the KRS number: 824985, NIP: 6783183556, REGON: 385364324 (hereinafter as the "Administrator"), we present the following privacy policy. The purpose of this document is to fulfill the obligations incumbent on the Administrator, resulting from the content of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on protection natural persons in connection with the processing of personal data and on a free basis the flow of such data and the repeal of Directive 95/46 / EC (hereinafter referred to as "GDPR") term the rules on which your personal data is processed, the purpose of such processing and your rights.

I. General information

In order to protect your data, the administrator appointed a data protection officer (DPO) with whom can be contacted by e-mail <u>iod@mbpower.pl</u>.

The administrator has obtained your personal data as a result of your voluntary submission at the company's headquarters or on the websites of which it is the operator.

II. Purpose and basis of data processing

Your personal data is processed by the Administrator in order to provide services and providing marketing information of the MBPOWER.pl company and entities with it cooperating.

Your personal data is processed:

- based on the legal basis expressed in art. 6 ust. 1 lit. a) GDPR on the basis and within your consent to the processing of personal data (if they were by States expressed);
- based on the legal basis expressed in art. 6 ust. 1 lit. f) GDPR on the basis of law legitimate interest pursued by the Administrator or a third party (entity cooperating with the Administrator), which consists in using voluntarily provided by Your personal data for the purposes of direct marketing of the Administrator or his partners.

Personal data is not used by the Administrator for any other purpose except this indicated above.

III. Categories of personal data

Your personal data subject to processing includes your e-mail address and number phone number provided on the website or on the form at the MBPOWER.pl headquarters.

IV. Recipients od personal data

The administrator does not intend to transfer your personal data to other recipients.

V. Transfer to third countries

The administrator does not intend to transfer your personal data to recipients located in a third country (outside the EOG area) or to international organizations.

VI. Processing period

Personal data will be processed by the Administrator until you use it from the rights listed in this Policy, which will result in the obligation to delete data personal data from the Administrator's collections or to refrain from processing, unless the law permits longer processing of personal data, e.g. for archiving purposes or defense against claims or pursuing claims.

VII. Rights related to the processing of personal data

In connection with the processing of your personal data by the Administrator, you have the following rights:

• the right to access your data and receive a copy of it;

You have the right to know what personal data relating to you are processed Administrator, as well as receive copies of this data.

• the right to rectify (correct) your data;

ou have the right to request the Administrator to correct your personal data that is incorrect or demand their supplementation.

• the right to delete data;

You have the right to request the Administrator to delete your personal data. Administrator despite the request made by a specific person, it may still process their data, if the obligation to further process data results from specific legal provisions or data processing by the Administrator is necessary for the establishment, investigation or defense claims.

• the right to request restriction of data processing;

You have the right to demand that the processing of your personal data be restricted to them only storing or performing activities agreed with you, if:

- In your opinion, the Administrator has incorrect data about you;
- The administrator processes your data unreasonably, but you request a restriction processing instead of deleting data;
- The controller no longer needs the personal data for processing purposes, but they are you necessary for the establishment, exercise or defense of legal claims.
- the right to object to data processing;

You have the right to object to the processing of your data for the purpose of direct marketing.

• the right to data portability;

You have the right to receive personal data from the Administrator in a file saved in the enabling its reproduction in a structured, commonly used format machine-readable (eg "csv" format).

• the right to lodge a complaint with a supervisory authority;

You have the right to lodge a complaint with the national supervisory authority appointed for the purpose personal data protection - the President of the Personal Data Protection Office.

VIII. Automated decision making and profiling

The administrator does not take any actions involving the automatic making decisions using your data.

You are also not subject to profiling based on the processed personal data.

The processing of personal data does not have any binding consequences for you legal or factual nature.
